Course description

This theory and clinical course focuses on the functions and responsibilities of the Associate Degree Nursing student towards the individual and his family within the community context. The concepts of primary health care, family structure, diseases affecting the community, and the three levels of prevention are all explored. The clinical part of this course allows the students to apply primary, secondary, ant tertiary disease prevention through the use of nursing process for clients in community settings.

- 5. Recognize the health needs of the individual, the family, and the whole communityby applying the approach of the nursing process.
- 6. Identify nursing roles and responsibilities in school health programs.
- 7. Identify family assessment, functions, and different roles offamily members.

- 1. Integrate the nursing process in assisting individuals and families to obtain their optimum level of wellness.
- 2. Discuss major chronic and communicable diseases in Jordan and interpret theirrelationship with determinants of health and control measures.
- 3. Discuss major social issues that affect the community health in Jordan such as accidents, and family violence.

- 1. Apply health education principles for solving the client, family and community problems.
- 2. Participate in the assessment of school health environment.
